Chile

Chile continues to be a strong trading partner and export market for U.S. companies, largely due to its open market policies, zero tariffs, democratic government, solid business practices, and low corruption. Chile is consistently the highest-ranked country in Latin America in terms of economic competitiveness. As the United States-Chile Free Trade Agreement concludes its eighteenth year, trade of products and services between the two countries continues to be a resounding success. As of January 1, 2004, duties were reduced to zero on 90 percent of U.S. exports to Chile, and in January 2015, all remaining tariffs were phased out, such that all U.S.-origin products enter Chile tariff-free.

Peru

Peru has been one of the fastest growing Latin American economies. Its prudent macroeconomic and fiscal policies, openness to trade, and growing middle class make Peru one of the best places to do business in South America. Peru is well integrated in the global economy through its multiple free trade agreements, including the United States-Peru Trade Promotion Agreement (PTPA), which entered into force in February 2009. In 2021, trade of goods between the United States and Peru totaled USD 17.2 billion, up from USD 9.1 billion in 2009, the year the PTPA entered into force. Its economy is expected to grow 3% in 2023.
